- A1 Emerging Sexual Trends Among Our Youth is Leading to Higher Risk of Abuse**

This session will discuss the recent sexual trends in our youth including sexting, sex messaging, pornography addiction and explore the intervention and prevention to protect our youth.

The incidence of PTSD in foster children is much greater than that of returning combat veterans, and the cost to society of this damage is staggering. After this session, attendees will be able to relate the special medical and mental health needs of the foster care population, describe several ways in which early trauma has been seen to affect the brain's anatomy, and demonstrate some ways to help a caregiver avoid making this damage worse.
